If the entrant is a minor, I, the minor's parent or legal guardian, understand the nature of bicycling activities and the minor's experience and capabilities and believe the minor to be qualified to participate in the Harmon Hundred. I also authorize emergency medical treatment if I or the above minor is injured.
